



# SOCIETY LOTTERY EVENT RETURN FORM

## Notes to Applicants

This return form shall be completed by an Isle of Man Society registered with the Gambling Supervision Commission (GSC) as a Society Lottery under Section 33 of the Gaming, Betting and Lotteries Act 1988 (the Act) and approved to promote lotteries played as games in the Island in accordance with Section 34A of the Act.

Section 34A of the Act provides that a society lottery is not unlawful if it is played as a game and complies with such conditions as may be prescribed. These conditions are prescribed within the Bingo Nights (Prescribed Conditions) Regulations 2010 (BNR); and the Racing Nights (Prescribed Conditions) Regulations 2010 (RNR).

This return, which must be certified by a member of an approved accounting body, must be provided to the GSC no later than the end of one month after the month in which the winners of prizes in a lottery are ascertained, the promoter shall deliver to the Commission a return.
