

APPLICATION FOR REGISTRATION OF A SOCIETY LOTTERY

Notes to Applicants

This form should be completed on behalf of an Isle of Man society wishing to apply to the Gambling Supervision Commission for the purpose of promoting a lottery in the Island as a "registered society" in accordance with the <u>Gaming, Betting and Lotteries Act 1988</u>.

The GSC has written guidance notes to assist in the completion of this form. They can be found on our website.

The Registration year runs from 1 January to 31 December. Registration as a society lottery is valid only for the calendar year in which it was applied. Therefore if you apply for registration on 1 December, it will only be valid to the 31 December of that year. Each registered society shall pay the statutory fee of \pounds 5.00 for registration for each calendar year it is registered.

The Promoter of the Society must be authorised in writing by the Society to act for it and will be the person designated as the main point of contact for the Society both in terms of this application and all gaming activity as defined under the Gaming, Betting and Lotteries Act 1988.

The Promoter's attention is draw to the Gaming, Betting and Lotteries (Society Lottery Advertisements) Regulations 2011 regarding the requirements of any advertisement commissioned by the Society.

All advertisements commissioned by a society must not contravene the advertising standards used by the Advertising Standards Agency of the United Kingdom.
